1. CONSTITUTION OF THE REPUBLIC

The first thing that must be corrected, is the country's Constitution, nowhere in the world, you would find a constitution that gives visitors equal rights as citizens of that specific country.

Operation Dudula would like the world to know that, South Africa does **NOT** belong to **ALL THOSE** who live in it, it belongs to South Africans. OD's government shall amend the constitution as a matter of extreme urgency. In the event we don't get two thirds majority, Operation Dudula would vote together with such organizations that seeks to change the constitution to "Put South Africans First".

2. UNFORGIVABLE SINS

- a. This offense must be punishable by not less than 25yrs direct imprisonment and 10 yrs for a distributor.

- b. Operation Dudula would classify nyaope and/or similar drugs punishable by the law.

5. Consciously harbouring criminals

- a. Operation Dudula shall apply/lobby for a Declaration of the State of Emergency on all undocumented and illegal foreigners in the first 6months post the 29th May 2024.
- b. Landlords, employers and families that are found to be guilty of the offense will be charged, and
- c. Be sentenced for a minimum of 5yrs in direct imprisonment.

3. OD ON ECONOMIC DEVELOPMENT

Problem Statement

- South Africans is not a poor country, most our problems are a direct result of economic mismanagement, corruption and incompetence.
- South African needs a government that would diligently and urgently reverse some of the skewed agreements made with developed economies.
- It is an open secret that big business has lost confidence in the state's ability to get the economy back on the positive growth trajectory. The gray-listing is dark cloud that affects foreign direct investment that this country is desperate for.
- These together with many other factors are contributing factors to the reasons why South Africa is not creating jobs.

Operation Dudula's promise

1. Based on the above, Operation Dudula promises to create and maintain a conducive business environment to encourage investment and entrepreneurship.
2. Operation Dudula promises to ensure that, for a considerable number of years, South Africa is turned into a permanent construction site, we will invest in and maintain critical infrastructure projects like
 - a. Road & bridges
 - b. Water provision
 - c. Electricity network upgrade & maintenance
 - d. Social Housing etc

3. OD ON ENTREPRENEURSHIP DEVELOPMENT

- a. Developmental funding institutions have failed our entrepreneurs by being an extension of commercial banks in South Africa.
- b. Deserving entrepreneurs will either receive developmental funding or adequate funding to development locally based businesses.
- c. As an attempt to protect the state's investment on natives, Operation Dudula will prohibit/criminalize foreign ownership of spaza shops & super markets, hair salons, shebeens & fruit & vegetables to mention a few.
- d. Operation Dudula's government will ensure that competition is controlled to ensure that state funded enterprises are profitable so that same can contribute back to the country via appropriate tax schemes.
- e. Operation Dudula further promises that under its watch, townships will no longer be a distribution channel for counterfeit goods.
- f. Business colleagues will provide entrepreneurship as a state funded course/program for all student who are already out of the compulsory schooling face.
- g. Entrepreneurship shall be part of the curriculum at a secondary school level.

4. OPERATION DUDULA ON HUMAN SETTLEMENT

PROBLEM STATEMENT

Lack of enforcement has allowed undeserving persons to occupy RDP houses and/or Social Housing Units that are developed exclusively for low to middle earning South Africans.

OUR PROMISE

- a. Every qualifying South African applicant earning below R5500 must be 100% subsidized.
- b. All subsidized persons(earning some income) must pay for the consumption of municipal services as determined by the policy or a relevant council resolutions.
- c. As an attempt to cover the missing middle, government would introduce a Rent to Own Schemes.

- d. Reduce the waiting & turn-around period, post approval, government would use approved and advanced technology to build houses.
- e. No undocumented foreigner would occupy a government funded house in South Africa.(no sub-letting or fronting)
- f. No South African shall rent out/or sell a property to an illegal or undocumented foreigner.
- g. No undocumented/illegal migrant shall own property(ies) in South Africa, Operation Dudula is aware of persons buying properties under companies that are not trading; this is happening in Bramley, Rosettenville, Kwadukuza, Morningside, Beach-front in KZN and many other parts of the country.
- h. Financial Intelligence Centre Act requires that property rental/sale transactions must be recorded and auditable. As we speak now, we don't know the tenants in all hijacked buildings in various towns and cities.
- i. Under Operation Dudula's government each and every building manager/property owner and/or estate agent must have an electronic file of tenants and visitors at all times, this must include pic and finger prints.
- j. The state will continue to give deserving South Africans housing, water and related services.

5. HEALTH

- a. Operation Dudula believes in a single health profile, a single health insurance that provides equal service to all South Africans.
- b. All voting wards must have fully equipped and functioning healthcare facility supported by a well-equipped regional hospital.
- c. Now that the Department of Home Affairs is busy digitizing citizens records, all clinics and hospitals (public and private) must be equipped with the necessary tech to obtain a pic and finger prints for verification with **Home Affairs, SAPS and Interpol.**
- d. Centralizing patient database and automating consultation at public health facilities shall reduce long and unnecessary queues, time spent at each facility and account for every medication prescribed and dispensed to each patient by ID and address
- e. Public clinics will be opened for 24hrs without any exception.
- f. Registered patients far from clinics and hospitals will have 24hr online access to a health practitioner and adequate ambulance

services to link patient with emergency cases to public health facilities. (This means no person shall be denied health service because of their location or distance)

- g. Most importantly, under Operation Dudula no patient shall collect medication from 6 different public health facilities.
- h. Under Operation Dudula, all foreign patients or their respective governments shall be billed for all medical bills.
- i. Foreign missions shall sign an SLA with the National Department of Health to ensure that foreigners in our country are identifiable and can be insured by the own countries.
- j. Under Operation Dudula, each public health facility shall be rated on the quality of service provided.
 - i. From time of arrival
 - ii. How much time did you spent before you exit any public health facilities?
 - iii. Time stamped touch points (who saw you, for what, what was the outcome including meds prescribed)
- k. To avoid medical theft, dispensing Dr's must be linked to the pharmacy technologically(pharmacy staff must not be allowed to change the prescription without a Dr, this means that a Dr must have a full view of the inventory)
- l. Under Operation Dudula, everyone (rich or poor) must have access to quality healthcare.

6. EDUCATION

- a. Basic education shall remain a right extended to every child at a school going age.
- b. Each public school shall receive sanitary towels as part of their monthly allocations to protect girl children from poor households.
- c. All kids shall be served a healthy meal prescribed by the Department of Health or by appointed dietician.
- d. All public schools shall receive unlimited wifi to enable a healthy learning environment
- e. All public schools shall have a 24/7 access to a social worker and an Educational Psychologist.
- f. For fear of human trafficking, each child must be linked to their parent via a DNA and unabridged birth certificate or biometric profile.
- g. No child shall be accepted at any school (private or public) without parental verification.(All parents must be legal in SA)

- h. Each school shall keep a full record of a pupil who drop out of school before the end of a lawful academic calendar.
- i. No school going child must be loitering during school hours unless accompanied by an adult who could account for the child.
- j. Under Operation Dudula, every child between grade 10 and grade 12 shall be taken to boarding school.
- k. A 12 month military training after grade 12 shall be compulsory to all kids out of school
- l. A child who has attended a boarding school and have obtained military training shall be considered for 100% higher education bursary by NSFAS.

7. HIGHER EDUCATION

1. Under Operation Dudula, Department of Labor shall conduct a national skills audit through various SETA's (security officers, teachers, construction workers, driving etc)
2. Where there is an abundance of skills, Operation Dudula will immediately criminalize the employment of foreign nationals in sectors with the abundance of skills.
3. To avoid graduate redundancy, all institutions of high learning shall produce /develop students for specific economic sectors to avoid skills shortages.
4. Under Operation Dudula high education qualification in accordance rare skills shall receive 100% and be prioritised for admission.
5. Each sector of the economy must have a plan to re-skilling/up-skilling and/or repurposing redundant skills or economically inactive persons.

8. LABOUR & EMPLOYMENT

- South Africa's unemployment rate at 32.9% is amongst the highest in the world.
- Over and above this reality, there are about 17m South Africans that are economically inactive, a considerable percentage is made of citizens that just lost hope, this should be reversed.
- Persons between 18 and 35yrs old must be reskilled to close gaps in specific industries and/or sectors of the economy.
- Medically fit or fit for purpose persons shall be given work experience to support labour intensive economic sectors.
- During this period of reskilling, they shall receive a stipend for the duration of the training programme before placed permanently at work.

- Employers who employ foreign national in sectors forbidden (non-critical skills) by law shall be held criminally liable without an option of fine.
- The Department of Labour shall immediately build capacity in the labour inspectorate unit, this is to ensure that each sector has sufficient/adequate labour inspectors.
- CEO's of all SOE's must be competent, credible and not be chosen on the basis of their political affiliation.
- Stop stealing public money and give the economy the skills needed before you start importing skills. It is a global practice you don't import what you don't need, why do we import drivers, doctors, teachers, housekeepers when we have our own?
- It is time that labor inspectors stop taking bribes. It can't be correct that factories in Mandeni, farms in Marble hall continue to employ undocumented foreigners while there are designated labor inspectors.
- It has been proven that a fine alone is not enough because employers can afford and budget for it. Under Operation Dudula, employers who are importing entry level skills are working against the country and shouldn't be allowed to trade.
- No undocumented foreigner will work or trade in SA
- No foreigner will work in SA unless they bring rare skills/expertise, even in this case a responsible SETA must provide labour with a plan to close that specific skills gap.

9. LAND

- UNTIL all ancestral land is claimed and in the hands of deserving claimants, the state should expedite the land retribution project.
- Operation Dudula supports expropriation of land and properties without compensation only when owners are absent and untraceable.
- Land shall be expropriated for social housing or developmental purposes.
- Operation Dudula appreciates that 20% of the country's land is already under the care and administration of traditional leaders, this should remain as such and should be removed from any land discussions.
- Under Operation Dudula, traditional leaders shall not be reduced to messengers for councillor, Operation Dudula shall ensure that a

developmental agreement shall be signed all land developers and the state

- i. This will ensure that all promises made by the state are reduced to a measurable agreement.
- ii. This is to ensure that villagers participate fully in the vision board of their respective villages.

10. IMMIGRATION

- a. Commanders, Operation Dudula does not believe in the integrity of SA's population register because of corruption at Home Affairs.
- b. Our position is confirmed by the fact that the Minister of Home Affairs has just stopped/cancelled about 500 000 duplicated ID's; we believe there are millions of fraudulent ID's and Permits in circulation.
- c. Until there is an audit by an Independent body, Operation Dudula is calling for a mass deportation of anyone who holds a permit less than 10yrs.
- d. Under Operation Dudula, South Africa shall donate land parcels to the United Nations for camps to establish refugee camps that will accommodate not more than 150 000 refugees and asylum seekers.
- e. Under Operation Dudula, study Visa shall only be limited to 10 000 students per annum.
- f. South Africa under Operation Dudula, shall cancel & drastically reduce the number of VISA to stop abuse of our immigration laws.
- g. Operation Dudula shall first withdraw its participation across all international conventions/treaties/protocols and reapply on new terms.

11. INTERNATIONAL RELATIONS

- a. Operation Dudula will review all commercial agreements/treaties and conventions with foreign countries and renegotiate the terms.
- b. Our minerals shall first benefit South Africans, in the event foreign countries need to participate in processing our minerals for commercial use, such industries must be established in SA as foreign direct investment
- c. Operation Dudula would seek to sign extradition agreements with all countries willing to do business and/or have a friendship with SA.

- d. Any country, not willing, to sign an extradition agreement would not be allowed to have its foreign missions in SA.
- e. All visitors coming into South Africa must produce proof of private medical insurance and/or a commitment by their country to cover uninsured services.

12. SOCIAL WELFARE

- By the 29th May 2024, more than 25m citizens will continue to be dependent on the state for survival. More than 16m South Africans have given up on either being employed or being entrepreneurs.
- South Africa is on the verge of being a welfare state, a father, mother and a child are queuing for some kind of a social grant by the state.
- Operation Dudula would develop a special entrepreneur development scheme for South Africans between 36 years and 55yrs (missing middle) to improve their survival chances and delay dependence on the state.

13. JUSTICE & CORRECTIONAL SERVICES

- a. Correctional service spends a minimum of R400 per prisoner per day and a R350 per voter per month.

400x30days

30daysx12months

12monthsx3

Assuming every prisoner spends 3yrs in prison, doesn't not get sick or study, the state spends about R500 000(half a million per prisoner)

- b. Unless you give prisoners another chance to live, they will go back to crime, Operation Dudula will intensify the state's capacity to rehabilitate prisoners so that the department could remove their criminal records and give them a second chance once they are declared/confirmed rehabilitated.
- c. Under Operation Dudula, SA will improve the capacity of the judiciary and the prosecution authority with the aim of reducing the time it takes to conclude cases.
- d. There will be no bail for drug dealers especially if their foreigners in SA, the costs of their stay will be posted to their country of origin.

CLOSING STATEMENT

- This manifesto demonstrate that migration cuts across education, health, employment, entrepreneurship and crime prevention in South Africa.
- It is common knowledge that foreigners are ready to pick up arms and kill South Africans in their quest to protect their gains.
- The world has witnessed foreign nationals standing up against the South African Police Services and Zama Zamas against the SANDF.
